**ADVERTISING RATES**

The base month-to-month (MTM) charge is \$40 per month. Discounts for multiple months are 5% (3 months), 7% (6 months), and 15% (12 months). There are four advertising categories: (1) No charge for ads for the sale of QC residents' personal property. (2) No charge for any businesses already paying a QC facility usage fee. (3) 50% of the base rates for QC residents' business advertising (home-based business or not). (4) Base rates displayed in the table below apply for ads for nonresident commercial activity unless Category 2 applies.

Setup charges per ad for nonresidents will be \$25 for text only or \$50 for text and graphics. Changes in the ad will incur additional setup charges. For businesses in Category 2 above, setup charges will be waived upon receipt of complete, ready-to-publish electronic ad copy.
